FACILITIES IN BOOTH

B) Nailing on the walls will not be permitted.

STAGE SHOWS & PERFORMANCES

Shows & video projections will be allowed but the volume should not exceed the sound level of 40 dB for the benefit of other exhibitors.

DAMAGES

Exhibitors will be required to make good all damages or make payment in lieu thereof of the Fair Venue facilities incurred during Setting up, Fair period or Dismantling period.

INSURANCE

Against all ascertainable risks from transportation to display and removal is to be arranged by the Exhibitor at their own cost.

DESIGN APPROVAL

Every exhibitor will have to submit their stand design for approval by 12 February 2018 along with scale mock up.

REMOVAL OF MATERIALS

No materials once taken inside will be allowed to be moved out from the Fair Venue during the exhibition period without the prior approval of the organiser.

Display materials along with construction material of the exhibitors will have to be removed by 26 February 2018

CANCELLATION

If the exhibitor withdraws his participation after confirmation the organiser reserves the right to forfeit the amount or part thereof against expenses already incurred.

SETTLEMENT OF DUES

Any additional payments due to CII or the Contractor have to be settled before the Exhibitor removes the materials from the Exhibition Venue.

SECURITY

The organiser will provide general Security and No entry to the premises will be permitted after the exhibition timings.
